Abstract: Back in 2014, AICON began to offer breakfast free of charge to attendees of their 16th biennial convention, this year held in Washington DC, and the breakfast experience attracted considerable interest amongst those attending the convention. The last time such a large breakfast had been organised for attendees of a health research conference was during the ASTROBSE session. Since then, there has been a desire to capture the breakfast experience as objectively as possible. We have created a database of the attendees and non-attendees at AICON 2016 that includes the breakfast, lunch and dinner locations and the times they were served. There was a strong motivation to study the breakfast attendees as it is the most commonly skipped meal at the AICON meeting. This publication includes a brief summary of the results of the analysis of the AICON 2016 Breakfast Attenders and Non-Attenders which found that those that attended had a higher mean BMI (27.1 vs 25.7), a higher mean male to female ratio and a higher percentage of females attending (
